#### 3. Montpelier Descendants Committee: Projects and Partnerships



The Montpelier Descendants Committee (MDC) leadership plans to provide an update on various ongoing projects aimed at recognizing and honoring the enslaved individuals at Montpelier and the nearby plantations. These projects include the Memorialization Project, which involves creating and installing a memorial for an enslaved burial ground containing approximately 300 unmarked graves. Additionally, the committee is working on the Arc of Communities Initiative, or "the Arc," which aims to identify significant sites of remembrance throughout Central Virginia that are linked to free communities, towns, and former locations of enslavement across the region. The MDC will also acknowledge the vital partnerships that are supporting these initiatives and will offer opportunities for descendants to participate in these efforts.
